#### 1. Wearing of Masks

### Covid 19 - Return to Learn Plan - 2023-2024 Year

#### Rationale for Return to Learn Plan

- Our main goal is to ensure that our students, staff, and families are remaining safe and healthy.
- A second priority is ensuring that we are keeping our students in school and avoiding remote learning situations.
- 3. We are required by the American
  Rescue Plan of 2021 (ARP) to
  develop and implement a Return to
  Learn plan with public input. The ARP
  requires 9 components for the
  Return to Learn Plan which is the
  basis for our district plan.

<u>Rationale</u> – Masks are proven to mitigate the spread of Covid-19.

#### 2. Physical distancing

Desks will continue to be separated
 as much as possible in each
 classroom. Close contact group
 classroom activities will need to be
 eliminated if we see any type of
 school spread.

<u>Rationale</u> - The CDC still recommends physical distancing as much as possible.

#### 3. Handwashing and cleanliness

 The school will continue to promote good hygiene practices and will provide hand sanitizer throughout the school.

<u>Rationale</u> - Continued good practices in this area will not only help with Covid spread but will also help during cold/flu season.

#### 4. Healthy Facilities and ventilation

- The custodial and maintenance staff will continue with enhanced cleaning and sanitizing practices.
  - The district has already made improvements to the building ventilation system.

<u>Rationale</u> - Enhanced sanitizing practices will continue to be beneficial to stop spread of any type of illness.

#### **5. Contact Tracing/Quarantine Procedures**

- The school district will comply with all current state and local health district requirements and recommendations.
- Students will be provided with opportunities to stay caught up with school work while absent and to make up school work once they return (refer to absence policy in handbook). High school students will not be subject to a reduction in credit if absences are due to covid.

Rationale – Contact tracing and quarantine

can help to mitigate the spread of covid in our schools and communities.

#### 6. Screening and Testing

- Students will <u>not be</u> screened upon entering the building. Families should continue to screen for symptoms before coming to school each day. - The school district will reference recommended Screening, Exclusion, and Re-Admittance guidelines from the local health department.

Rationale - While screening at school can be helpful, we do not have a need at this time to continue with this

- Vaccinations remain a family and/or individual choice.
- However, the school district will coordinate with our local health district to promote opportunities for staff and student vaccinations as needed.

# 8. Accommodations for children with special needs

 The district will continue to follow all IEP and 504 plans. Individual student health needs should be addressed within these plans. <u>Rationale</u> - The school district will always follow applicable federal and state laws.

### 9. Coordination with State and Local Health Officials

- The school district will continue to seek out and consider the advice of state and local health officials.
   Changes to our plan will be considered as needed.
- We will review and revise our plan a minimum of once every 6 months as required by the ARP.

Rationale - Covid 19 has provided a lot of unpredictability. It is important for our district to continue to seek out guidance and make changes as needed to keep our students, staff, and community safe.

## 10. Policy to address documented classroom/school Covid spread

The school district will continue to monitor covid spread in our district and community. If there is documented spread within our school, we will work with the health department to consider options to mitigate spread.

### 11. Exclusion, Screening, and Re-Admittance Protocols

The school district references the Nebraska Association of Local Health Directors recommended guidelines for exclusion, screening, and testing. Families should work with their health provider and school to determine periods of isolation (positive) and quarantine (close contact with positive case).

#### **12. Other Components**

- Every effort will be made to first approve any changes to this plan via the Creighton Board of Education (BOE). However, the Creighton BOE has authorized the superintendent the ability to make immediate changes if needed to protect our students and staff as well as to keep our schools open. Any changes to this plan will be communicated to all families in a timely manner.
- Food service School administration will continue to collaborate with our food service staff to provide food in a safe, sanitary manner.
- Drinking fountains will be available.
   However, Students are encouraged to bring and use their own water bottle during the school day and during school activities.
- <u>Transportation</u> Our school district will make every effort to spread students out on school busses to the greatest extent possible. If a positive case is documented or we have spread within our schools, masks may be required on busses and school vehicles.
- Schedules/Shared Classroom Use Elementary and middle level
   students will be able to travel to and
   use shared classrooms (middle level
   core subjects, PE, music, art, etc.).
   Administration will make changes as

needed with traveling classes if our situation changes.

#### 13. Plan Timeline

 All Return to Learn Plans should be posted on district websites no later than July 15th, 2021. All plans should be reviewed every 6 months for the next two years.

#### **14. Public Input Timeline**

- 8/20 Policy committee met to review new recommendations from the state and local health department
- 8/25 Covid Response Information
   Team (policy committee and 4 local health professionals) met to review new recommendations from the state and local health department
- 8/26 Survey was created and shared with families and community members via our website and social media.
  - 8/30 School board reviewed survey data and voted 6-0 to approve proposed changes.
- November 4th- Policy committee met to review R2L plan.
  - November 5th Letter was sent to families with clarification and reminders.
